## Introduction - Our Organization Philosophy

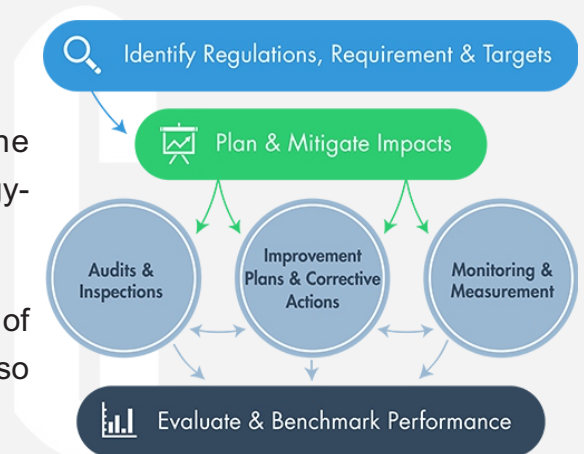

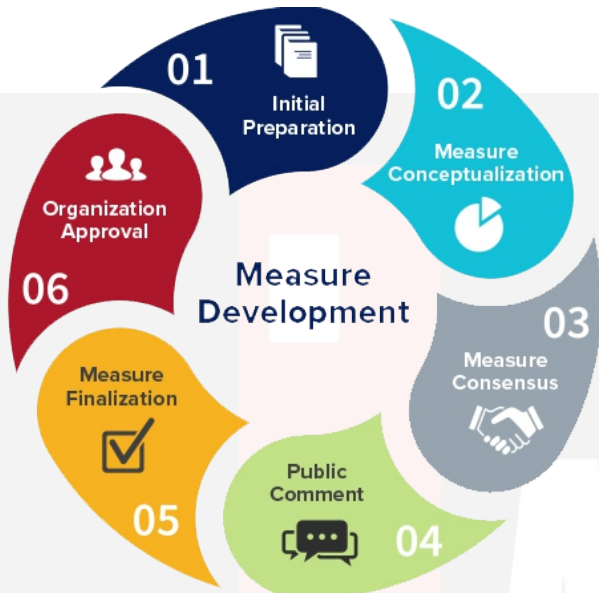
